Fee Increment and Deferral of the Increase from 4.5 to 6 Hours of ECPD for 2023/2024

Fee Increment

Since the financial year 2019/2020, the Institute's annual subscription and renewal fees have remained unchanged. During the pandemic period, the Institute provided members, graduates and students a 10% discount on annual subscriptions, renewal fees as well as on ECPD seminars.

Starting from 2023/2024, the Institute's Council has resolved to adjust the annual subscriptions, renewal fees and election fees for members, graduates and students. 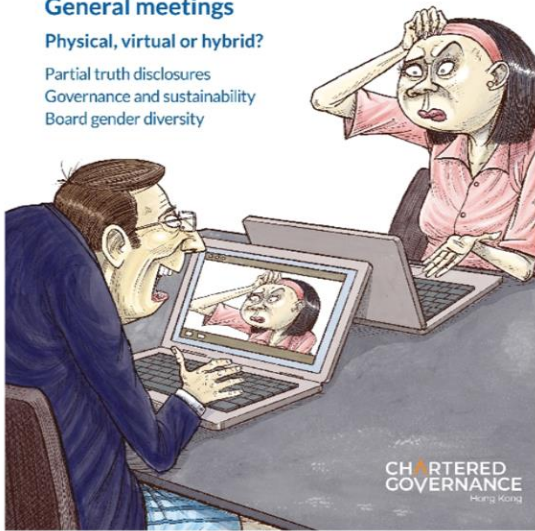
