In July 2021, the Institute changed its name to The Hong Kong Chartered Governance Institute (HKCGI). While the post-nominals from our affiliated international body 'The Chartered Governance Institute (CGI)' remains unchanged, the current HKCGI post-nominals 'FCS' or 'ACS' will expire on 31 January 2022, and as from 1 January 2022, the new post-nominals 'HKFCG' or 'HKACG' should be used instead. There is also the option for members to combine the new post-nominals with the professional qualifications, namely Chartered Secretary (CS), Chartered Governance Professional (CGP), and Practitioner's Endorsement (PE).
