For receiving physical papers for the AGM, which we do not encourage, this needs to be done before 6pm, 2 November 2021.

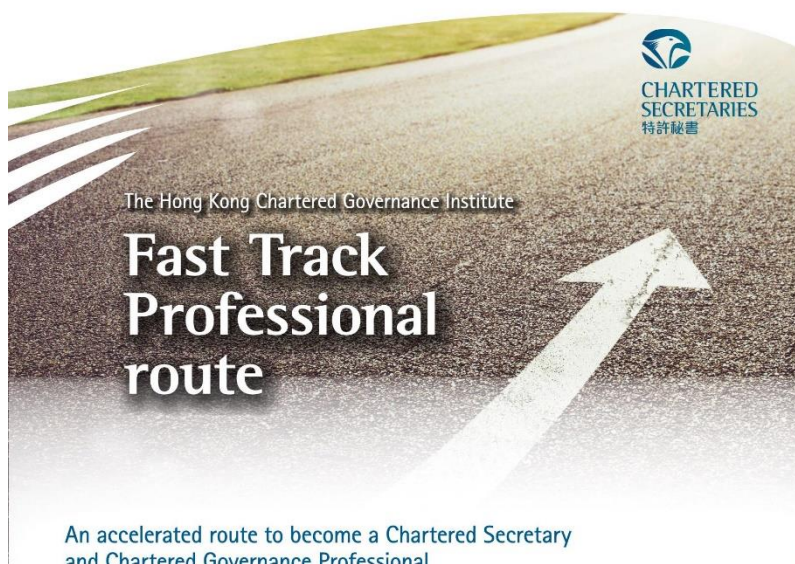

New policy effective from 1 July 2021

Institute students whose studentship is about to expire within the next three months will receive their renewal notice via email on 1 October 2021. The renewal fee must be settled by Friday 31 December 2021, failure to comply will result in studentship removal.
